Form prep for Proxy Vote Inquiry	BEFORE sending out election email.	This is in lieu of emailing the secretary. Copy blank template into new form for current year's election. Inform membership of upcoming elections and open nominations.	One <b>month</b> before election date.	Notification is by email: template is in Mailchimp. Send out email, and post link to email on relevant outlets. (Discord, FB, Twitter, etc.)

Post physical information regarding elections in TheLab's location.	One <b>month</b> before election date.	
Coordinate with secretary to fill out election nominations chart on KB.	One <b>month</b> before election date.	Secretary should fill out relevant nominations and post to KB page as they are accepted. Persons nominated must have been a member for at least 6 months.
Post Meetup date with election info.	One <b>month</b> before election date.	Meetup should include link to Mailchimp email and nominations KB.
Close nominations.	One <b>week</b> before election date.	All issues/nominations must be submitted one week before the Annual Meeting. Secretary must check that KB is up-to-date.
Edit electronic ballot.	One <b>week</b> before election date.	
Call for final proxy votes via Discord and at physical location.	<b>Two days</b> before election date.	Note that proxy votes <b>MUST</b> be in 24 hours before the date of the election.
ID checks	<b>Before</b> or on election date.	Confirm in WHMCS that persons have shown their ID to at least two members of the Board of Directors.
Set up voting computers and/or QR codes.	<b>Two days</b> before and on election date.	Members may use computers set up in-person to vote on, or, be provided a QR code to scan and vote from their smartphone.
Email ballot to proxy voters.	<b>3:00pm</b> , day of election.	Secretary should email a link to the electronic ballot at 3:00pm, the day of the election.
Open the polls.	<b>3:00pm</b> , day of election.	Members may vote.
Close the polls.	<b>5:00pm</b> , day of election.	Polls are closed to further votes, including proxy votes.
Vote count.	<b>5:00pm</b> , day of election.	Votes are confirmed by the Secretary, and a previous floating board member.
Announce results.	After <b>5:00pm</b> ,	Secretary will post to the KB page newly elected persons.
